1. Qualification and Age limit for the above posts are as under :

- i) **Driver Constable:-** Class VIII passed with Valid Light & Heavy Driving Licence: Minimum 21 years and maximum 38 years (one time relaxation) as per Office Memorandum NO.AR/ESTT-10/4/2024 Dated 26-02-2024.
- ii) **Firefighter:-** Class VIII passed. Minimum 21 years and maximum 38 years (one time relaxation) as per Office Memorandum NO.AR/ESTT-10/4/2024 Dated 26-02-2024.

Candidate will have to apply only in 1 (one) post by clearly indicating the desire post.

2. Disqualifications:

- (i) The following medical conditions of a candidate shall stand disqualified appearing in the Recruitment Test.
- a) Squint eye and colour blindness condition.
 - b) Hearing problem and Knocked knee.
 - c) Cardiovascular and respiratory system problem.
 - d) Varicose vein.
 - e) Flat Footed.
 - f) Amputated Limb/Infirmities.
 - g) Any other medical defect.
- (ii) The candidates will be required to undergo various tests as directed by the department including Medical, Physical, Written and Oral Tests. Failure in any of the test will disqualify the candidate. Medical Fitness Test/conditions will not be counted for merit but of only qualifying criteria.
- (iii) Incomplete documents/unsigned application and failure to indicate the post applied for.
- (iv) Failure to use prescribed application format and examination fee of Rs.300/-.
- (v) Non attestation of certificates/documents.
- (vi) Candidate applying for more than 1 (one) post and will be summarily rejected.
- (vii) Canvassing/using any unfair means during recruitment test.
- (viii) Using fake certificate.
- (ix) The character and antecedents of selected candidates shall be verified through Police before appointment, and any adverse report shall disqualify a candidate for appointment.

No application form will be supplied by the concern Department.


