Directorate of Fire & Emergency Services, Nagaland

INTRODUCTION :

The State Fire & Emergency Services was set up in the late 1960's with the nomenclature "Nagaland Fire Service Organization". The organization was a part of Police department but later on it was bifurcated from Police department w.e.f. 1-4-1990 and declared as a separate Directorate under the administrative control of Home department. The Fire & Emergency Services is an organization, responsible for fire fighting to save life and properties, and rescuing people trapped in incidents and disaster management. There were records of serious fire incidents that has destroyed property worth crores of rupees from time to time.

With the rapid urbanization, development and other constructional activities, need is felt to state and organize it in a manner that the facility of Fire Service reaches to a common man and the losses to national wealth are restricted and controlled effectively.

The main objectives of Fire & Emergency Services are as follows :-

- a) To save the life and property.
- b) To conduct rescue operations and disaster management.

ORGANISATIONAL SET UP :

The organization has 16 Fire Stations located in Nagaland, Namely Kohima South, Kohima North, Dimapur Central, Dimapur West, Mokokchung, Wokha, Mon, Tuensang, Zunheboto, Phek, Chumukedima, Kiphire, Peren, Longleng, Tuli, Jalukie. It is directly under the Administrative control of Home department, and operational command control and administrative affairs is looked after by a senior officer of the rank of IG.(F & ES)

SPECIAL SERVICE :

Beside its basic fire fighting, the Fire & Emergency Services under taken standby duties at various important places like exhibitions, important fairs, VVIP visits and other important national and State functions.

The organization observes Fire Service week every year i.e. 14th – 20th April. The motto is "WE SERVE TO SAVE"

ACHIEVEMENTS :

- (i) Construction of Directorate building is in progress
- (ii) Fire Station Dimapur West was completed and inaugurated on 23/07/2019
- (iii) Fire Station Jalukie was completed and inaugurated on 05/02/2020.
- (iv) Central Workshop-cum-Garage at New Capital Complex, Kohima will be inaugurated soon.
- (v) Various Categories of 119 Fire/rescue call had responded and had saved property worth Rs.2011.80 Lakhs of state wealth

VISION :

- i) Basing on SFAC (Standing Fire Advisory Committee of India) and MHA criteria ,the department is eying for establishing 48 Fire station in the state.
- ii) Making the Fire Service organization a modern organization equipped with all required equipments to make fire fighting and rescue works more effective to save life and properties.
- iii) To establish Regional Emergency Management Training Institute (REMTI) for North East region. This institute will cater training on saving life and properties, and also various type of disaster.
- v) The Department is eying to construct rain water harvest reservoirs at all strategic locations in the state which can be used during fire emergency.
- vi) To enhance fire fighting capabilities through training and latest technology.
- vii) Impart fire fighting training/ awareness to public.

Superintendent, Superintendent. Matters having financial implications are processed by construction branch, MT Branch, R.O. Clothing Branch, Asst. superintendent, Superintendent, the files are submitted to the I.G.(F & ES) for decision.

Matters which require Government approval/sanction etc are send with the approval of the I.G (F & ES) to the Government.

Supervision :- The I.G. (F & ES) supervises the works of all the different branches etc.

Accountability :- The officers and staff are accountable for timely disposal of the works allotted to them.
